### Ten Simple Tips to Prevent Data Loss

If you'd like to reduce your chances of requiring data recovery, consider giving some of these free or low-cost tips a try.

- 1. Back-up your critical files.** With the ability to store data on CDs on a weekly or monthly basis, a small investment in a stack of CDs will save you from losing your critical documents, files, priceless images and MP3s.
- 2. Run an Anti-Virus Program.** Viruses get into your computer a variety of ways; by reading an infected attachment in your e-mail, by sharing files or by visiting websites that take advantage of security flaws to compromise and destroy your data.
- 3. Use power surge protectors.** A power surge, either from the power company or a lightning storm, is one of the most common occurrences that can damage your data and potentially cause a computer to fail.
- 4. [Experience required.](#)** Never attempt any operation, like hard drive installations or hard drive repairs, which you don't have experience with. If you don't know how to install a second hard drive, rebuild a RAID or transfer data it would be best to get [expert](#) assistance before you accidentally cause yourself data loss.
- 5. Shut down your computer correctly.** Always quit your programs before shutting down your computer. When you quit a program, it saves vital data and then exits the program. If you just turn off your computer without properly exiting your applications and closing your files, you run the risk of losing your data.
- 6. Never shake or remove the covers on hard drives or tapes.** Please don't disassemble your hard drive. In nearly all examples of this, data is usually not recoverable once an inexperienced person attempts to 'investigate' where that 'strange clicking noise' is coming from. Leave the diagnostics to a data recovery specialist who has experience with all types of hard drives and knows how to perform a successful data recovery.
- 7. Store your backup data offsite.** While it is always a good idea to backup your critical

data, if your data is stored at the same location as your server and there is a natural disaster, a fire or flood for example, odds are that you will still require data recovery on the hard drives, or tape restoration to get your data restored.

**8. Beware of Rogue/Suspect Anti-Spyware Products.** Never approve a scan from a pop-up screen warning you of a possible threat. These are scams to glean your money for removing "spyware" which that program just installed. Don't fall for this!

When checking the health of your computer and running cleaning software, be careful allowing 'No-Name' Spyware Removal programs of unknown, questionable or dubious value as anti-spyware protection. Check the [Spyware Warrior List](#) to see if that application you are about to install on your computer really does do what it says it does or not.

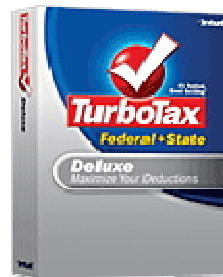
**9. Be aware of your surroundings.** Keep your computers and laptops in safe and secure locations from accidentally getting knocked over, dropped, or spilled on. Laptops, while convenient to use, are often dropped or spilled on requiring emergency hard drive data recovery. Padded cases and drinks with spill proof lids will save you hundreds of dollars.

**10. Backup your critical files.** Worth mentioning again. Using CDs or even an external USB hard drive for data storage can potentially save your business. It will also keep you from having to hire a data recovery service to perform hard drive data recovery on your hard drive or server.

### **What is your computer worth?**

A few years after you buy your computer not much. Computer equipment loses value at roughly 2% per week. What does this mean to you? What you purchase today is worth 2% less this week, 2% less of that total next week, etc.

### **Don't invest in computer hardware like you would real estate.**

If you paid \$1000 for a computer today, next year it will be worth \$300 and the year after that \$100. Three years from the date of purchase, it is worth about \$30. This estimation is close, but not exact.

Desktop computers have lost the most value in the past few years where laptops have maintained the most as many people have moved to portable computers.

### **What causes this devaluation?**

Faster processors, larger hard drives and less expensive memory coming out each year. Three years ago the hottest computers were P3 933mhz computers. Now, the hottest computers are close to 4Ghz. One can be sure there is a faster processor around the bend.

New computers being produced for less money. Most computer manufacturing is accomplished in Asia where labor costs are extraordinarily low. A basic home computer five years ago was \$1500. Now, one can buy a new computer for \$400 - \$700.

Oversupply in the used market from company shut downs, IT departments phasing out equipment faster and more efficiently and large reorganizations in the past few years have flooded the used market.

### **How can I find out the value of my computer or find its selling price?**

Try [eBay](http://eBay). The best way to find its value or to get a quick valuation is by selecting closed prices so you can see what has been sold and for what price. Do a search of your Make and Model number. You will find a list of comparable items. Sort by highest price and read the green (items that have sold) and you will be able to attain a fair market valuation.

If you choose to sell your computer or laptop on eBay, keep in mind that fixed pricing receives higher pricing than auction pricing. Price your laptop at the mid-range of all the fixed priced listings that you may have seen on eBay.
